<b>Social</b>	<p><b>Curfew:</b> eased to 9pm – 5am</p> <p><b>Leave home:</b> for 4 reasons and stay local (5km)</p> <p><b>Public gatherings:</b> increased to 2 people or a household that can meet outdoors for two hours maximum</p> <p><b>Visitors to the home:</b> increased to 1 nominated visitor if living alone/single parent (all children under 18) ('single social bubble'), professional respite care for people with complex needs allowed</p>	<p><b>Curfew:</b> not in place.</p> <p><b>Leave home:</b> only for 4 reasons, distance and time limits</p> <p><b>Public gatherings:</b> up to 10 people can meet outdoors for social interaction (infants under 12 months of age are not included in the cap).</p> <p><b>Visitors to the home:</b> 1 visitor and any children or dependents if unable to stay home.</p>	<p><b>Leave home:</b> no restrictions on reasons to leave home or distance but stay safe.</p> <p><b>Public gatherings:</b> up to 10 people outdoors (infants under 12 months of age are not included in the cap).</p> <p><b>Visitors to the home:</b> Up to two people can visit a household once per day. Dependents can attend if they cannot be left unattended or cared for in another setting. The two people may be from different households and can either visit together or separately.</p> <p><b>Face masks:</b> fitted face mask must be worn, unless an exemption applies.</p> <p><b>Visiting hospital and care facilities:</b> Visits to care facilities with visitor and time limits depending on care facility and visit type One household can visit a patient in hospital for 2 hours, once per day. No limit on people aged 16 and under can visiting in hospital. No time limit on partner or support person visiting maternity ward.</p>	<p><b>Leave home:</b> no restrictions on reasons to leave home or distance but stay safe.</p> <p><b>Public gatherings:</b> up to 50 people outdoors.</p> <p><b>Visitors to the home:</b> up to 15 visitors per day and can be from different households</p> <p><b>Face masks:</b> Face masks are no longer required outside if you can maintain distance (1.5 metres) from non-household members. Face masks are required indoors, including shopping centres, gyms and public transport. You always need to carry a face mask with you.</p> <p><b>Visiting hospital and care facilities:</b> No restrictions on purpose, number of visitors or length of time for visits. Hospitals and care facilities may set requirements, conditions or restrictions for visitors.</p>	<p><b>Leave home:</b> no restriction on reasons to leave home but stay safe.</p> <p><b>Public gatherings:</b> limits of public gatherings will increase, in line with public health advice.</p> <p><b>Visitors to the home:</b> limits of public gatherings will increase, in line with public health advice.</p> <p><b>Face masks:</b> Subject to public health advice.</p>

Auctions outdoors with up to 10 people, plus those required to conduct auction</p> <p><b>Shopping:</b> no person limits.</p>	<p><b>Hospitality:</b> indoor and outdoor seated service, density limits, and indoor limit of 150 patrons and outdoor limit of 300 patrons (with a total venue limit of 300). Smaller indoor venues (&lt;200 square metres) can apply a density quotient of 1 per 2 square metres up to a cap of 50 patrons. Indoor venues ≥ 200 square metres must apply a density quotient of 1 per 4 square metres up to a cap of 150 patrons.. Food courts open outdoors for maximum of 50 patrons per area and indoors for a maximum of 50 per cent capacity, subject to density limits.</p> <p><b>Retail:</b> all open. Beauty/personal services able to offer services where face masks need to be removed (facial waxing, beard trimming and piercings around the mouth, nose and cheeks).</p> <p><b>Real estate:</b> operating with density limits, group limits, safety measures and record-keeping.</p>	<p><b>Hospitality:</b> Some restrictions such as density limits and record-keeping of patrons to continue.</p> <p><b>Retail:</b> all open.</p> <p><b>Real estate:</b> operating with safety measures and record-keeping.</p>

Where a facility has an indoor and outdoor pool, the indoor limit applies indoor, and the outdoor limit applies outdoors, allowing a facility to apply both.</p> <p><b>Playcentres:</b> open. Patron limit of 150, subject to density limits.</p> <p><b>Skateparks:</b> open, outdoors and indoors for all ages. Patron limit of 150 indoors and density limits apply.</p>	<p><b>Fewer restrictions</b> on community sports and spectators. Indoor religious gatherings are allowed with a maximum of 20 people (10 per group) plus a faith leader attending with specific cleaning requirements and COVIDSafe Plans.</p>	<p><b>Weddings:</b> allowed with 150 people or 15 visitors in a private residence. This limit includes the couple and two witnesses. The celebrant, photographer and others working at the event are not included in this limit.</p> <p><b>Funerals:</b> allowed with 150 people (not including infants under 12 months of age), 15 visitors in a private residence. The people required to conduct the funeral are not included in this limit.</p> <p><b>Religion:</b> up to 150 members of the public indoors, or up to 300 members of the public outdoors; cannot have indoor and outdoor religious gatherings at the same time.</p>	<b>Weddings, funerals, religion:</b> limits of public gatherings will increase, in line with public health advice.

Large events treated on an individual basis based on requirements and epidemiology at the time.</p> <p><b>Stadiums:</b> Indoor venues open, with some limits.</p> <p>One-off events subject to requirements listed in the public event framework.</p> <p>Outdoor seated venues open, subject to density quotient, group limit of 50 and a maximum capacity of 500 people.</p> <p>Non-seated venues subject to density limit.</p> <p><b>Arcades, escape rooms:</b> open subject to density quotients, group limits of 20 and a patron limit of 150.</p> <p><b>Amusement parks:</b> open, density limits, patron, group limits, and larger permanent amusement parks will need to publish COVIDSafe Plans.</p> <p><b>Public events:</b> subject to the requirements listed in the public event framework.</p> <p><b>Accommodation:</b> open but bookings restricted to private gathering limit of household plus 15 visitors from any number of households.</p>	<p><b>Intrastate travel:</b> allowed</p> <p><b>Borders:</b> continued international border controls, state border controls activated in case of outbreaks.</p> <p><b>Entertainment venues:</b> open, safety measures and record-keeping. Limits of public gatherings will increase, in line with public health advice.</p>
